Please notify us of your decision to accept or decline your admission offer by **April 20, 2018**. If you plan to attend, your notice of acceptance must be accompanied by a non-refundable deposit of \$750. The deposit is payable online by credit card or you can mail a personal check made payable to Harvard University. If you mail a check, it must be received by **April 20, 2018**. The deposit will be credited toward your tuition when you enroll. Also note that you may not accept an offer of admission to more than one graduate program.

Your admission and registration for the fall are contingent upon receipt of all required official admission documents. You can view information on the documents our office needs to receive on your new admit portal. Please arrange to have official transcripts and any other required documents delivered to our office no later than **June 29, 2018**. Please also note that your enrollment is contingent upon completion of the financial certification process by **June 15, 2018**. Specific details of this process are noted on the new admit portal.

Registration and orientation are scheduled for **August 27-31, 2018** and classes begin on **September 6, 2018**. **Orientation is mandatory for all new students so please plan ahead.** Commencement is scheduled for **May 28, 2020**. Congratulations once again on becoming part of the HKS community. We look forward to your arrival.
